Re: 911 Primary Public Safety Answering Point (PPSAP) Service Contract Extension

The Woodstock Police Service presently provides 911 PSAPP services to the County of Oxford pursuant to a one-year contract extension that expired on January 12, 2024. The one-year extension was negotiated which included a 2% per capita increase. Chief Ryan Hall has indicated that the County of Oxford is prepared to sign the new attached agreement for a five-year extension from January 12, 2024 – January 31, 2029 which includes a 2% per capita increase each year.

### **Recommendations:**

That the Board authorize the Chair to sign the attached five-year extension to the current PPSAP Agreement between the County of Oxford and the Woodstock Police Services Board.

Board Report – January 2024 – OPEN SESSION INFORMATION

RE: Donation to WPS Police Canine Program

### **Background:**

Woodstock Police Service Dog (PSD) Striker is in his tenth year of service. The WPS developed a transition plan and purchased a new PSD Taz. Taz commenced training in 2022 to allow for a smooth transition towards Striker's eventual retirement. Unfortunately, Taz was killed in the line of duty in 2023. WPS vowed to continue the PSD program with the purchase of a new Canine. Five local businesses have approached the Woodstock Police Service and expressed a desire to financially support the WPS Canine Program with a combined donation of \$25000.00 towards the purchase of the new dog, equipment and training. WPS has accepted donations towards the Canine programs in the past.

The donations fall within the parameters of WPS Donations and Community Sponsorship Procedure #130WPS. I am satisfied that the five businesses have no expectations attached to the donation and are making the donation out or a strong support of the program and a desire to be good corporate citizens. I have approved the donation and have prepared this report to update the board on the additional revenue.
